



2022-2023 Flu Vaccine Options

Influenza (flu) is a contagious respiratory illness caused by influenza viruses. It can cause mild to severe illness, including hospitalization or death. The best way to keep your employees healthy and prevent flu-related absences is to offer a seasonal flu vaccine.

Summarized below are a few cost-effective options that plan sponsors can utilize to protect their members for the upcoming flu season.

		
Host an <u>Onsite Flu Shot Clinic</u> at your business - administered by a fully trained, certified immunizing pharmacist.	<ul style="list-style-type: none"> For businesses with 50 or more employees per location. On-site clinics are available in states that have a Rite Aid location. * All clinic locations must be within 20 miles of a local Rite Aid pharmacy. A minimum of 20 participants per hour for onsite immunization clinics. If a pharmacist is requested for an event with a smaller turnout, we will apply a staffing fee of \$60.00 per hour. Pay Rite Aid directly or process payment through your pharmacy benefit. 	<ul style="list-style-type: none"> A minimum of 30 vaccinations is required per 2.5-hour clinic. Longer clinics should be determined by 12 shots per pharmacist hour. On-site clinics are available in all states, with limited availability in some areas. All clinic locations must be within 30 miles of a local CVS pharmacy. All clinic dates must be made at least a minimum of 2 weeks in advance.
Send your employees to a nearby pharmacy - <u>Flu Shot Vouchers</u> for use at issuing Pharmacy	<ul style="list-style-type: none"> Clients will be issued a voucher (print or electronic) to be distributed to eligible participants that can be redeemed at a Rite Aid pharmacy. No appointment necessary. Rite Aid only bills for redeemed vouchers. 	<ul style="list-style-type: none"> Clients will be issued a voucher to be distributed to eligible participants that can be redeemed at a CVS Pharmacy or the on-site clinic. CVS only bills for redeemed vouchers.
Pricing	Discount options for direct-billing and flu shot volume are available.	Claim will be submitted to insurance for with which CVS has a contract.
